#### **APPROVAL OF MINUTES**

#### **OPEN FORUM**

Five Speakers: Wei-Ling Huber President, Maggie Gibson, Robert Preston, Tony Evans, and Kenyetta Gentry from Local Union 2850 spoke regarding the Levy contract soon to expire. All the speakers voiced their concern of losing medical and other benefits in addition to their positions of employment if the Levy agreement is not renewed. The speakers ask for OACCA Board for support in addressing their concerns of benefits and employment.

### 1. Accessible Voting Location

The County Registrar of Voters requested to use the Arena and parking lot for a major centralized voting location over a four-day period, including Election Day of November 3, 2020. The event was well organized and was carried out with no incidents. It was well staffed with County employees and a number of volunteers. Although it was initially intended to be a voting site only, the County decided to take advantage of what was a captive audience and added COVID-19 testing and, on the day of the election, flu vaccinations. It was difficult to estimate the number of people who would use the location and the actual use was less than what was anticipated. The event was well advertised and had a lot of exposure in a variety of news outlets. While it was an overall success, the number of people using the site was relatively modest. The number of vehicles entering the parking lot for voting was 1,516; COVID-19 testing 311; and flu shots 119. It appears that many voters voted early, mailed in their ballots or dropped off their ballots at other locations. The Oakland Athletics paid the expenses of the event and the actual costs came in under budget by as much as twenty percent.

# 3. Status of Negotiations with Coliseum Way Partners LLC (Oakland A's) for Purchase of Coliseum Complex Property

A request has been made to brief the Board on the status of the negotiations for Sale of the Property

The Coliseum Complex Property is owned jointly, fifty-fifty, by the City of Oakland and the County of Alameda. The County has entered into a Disposition Agreement for sale to the Oakland A's, subject to various conditions. The City of Oakland is in negotiations and has not entered into an agreement. We bring this matter to the Board for discussion only to begin to consider the implications of the future role of the Joint Powers Authority should a sale by both the City and County be consummated. Because the City has not entered into an agreement, the City has no specifics to present with regard to the provisions it may or may not be negotiating. Nonetheless, we think it appropriate that the Board begin to acquaint itself with the direction the City and County are pursuing.

## **RESOLUTION NO. 2020 - 04**

RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF AN ADVISORY SERVICES AGREEMENT, IN AN AMOUNT OF \$24,500 PLUS REIMBURSABLE EXPENSES IN AN AGGREGATE AMOUNT NOT TO EXCEED \$2,000, WITH THE BIGELOW COMPANIES, INC., TO CONDUCT A COMPETITVE SOLICITATION PROCESS, EVALUATE BIDDERS AND NEGOTIATE FINAL CONTRACT TERMS WITH THE APPROVED BIDDER FOR MANAGEMENT AND OPERATION OF FOOD AND BEVERAGE SERVICES AT THE OAKLAND-ALAMEDA COUNTY ARENA.

WHEREAS, the Oakland-Alameda County Coliseum Authority ("Authority") and Levy Premium Foodservice Limited Partnership, an Illinois limited partnership ("Levy") entered into that certain Arena Concession License Agreement, dated June 15, 2004, as amended multiple times, most recently with the Seventh Amendment approved by the Authority Board on April 17, 2020 (collectively, the "Levy Concession License Agreement") for the exclusive right to manage and operate all of the food and beverage concession services (collectively, "Food Services") in designated areas within the Oakland-Alameda County Arena ("Arena"); and

WHEREAS, the Term of the Concession License Agreement will expire on November 30, 2020; and

WHEREAS, the Authority desires to conduct a nationwide competitive solicitation process to engage a vendor to provide Food Services upon the expiration of the Levy Concession License Agreement (the "Food Services RFP Advisory Services"); and

**WHEREAS**, The Bigelow Companies, Inc., based in Kansas City, Missouri ("Bigelow"), is a nationwide firm providing design and management advisory services for the foodservice needs of clients with public assembly facilities; and

**WHEREAS**, Bigelow submitted the sole proposal, after a solicitation of proposals by the Interim Executive Director of the Authority, to provide the Food Services RFP Advisory Services as desired by the Authority; and

WHEREAS, Bigelow's proposed scope and terms of the Food Services RFP Advisory Services is set forth in Bigelow's proposal dated April 14, 2020, attached hereto and made a part hereof as Exhibit A (the "Bigelow Proposal"); and

NOW THEREFORE BE IT RESOLVED, that the Authority Board does hereby approve and authorize the Interim Executive Director to execute an agreement with Bigelow for the provision of the Food Services RFP Advisory Services on the same scope and terms set forth in the Bigelow Proposal, for an amount of \$24,500; except that such agreement shall 1) specify that any costs for reimbursable expenses shall not exceed an aggregate amount of \$2,000; and 2) shall require the Food Services RFP Advisory Services to be fully completed prior to November 30, 2020 (the "Agreement"); and

BE IT FURTHER RESOLVED that the Authority's Interim Executive Director is hereby directed to return, prior to November 30, 2020 but upon completion of the Food Services RFP Advisory Services by Bigelow, to the Authority Board with an analysis of the qualified bidders

and recommendation for the Board's consideration and approval of a new vendor for Food Services at the Arena; and

**BE IT FURTHER RESOLVED** that the Authority's Interim Executive Director is hereby authorized to execute the Agreement consistent with the authority granted herein, in a form to be approved by the Authority's Joint Counsel.
