## 1. Empower Retirement Plan Termination

We have engaged the consulting firm Sage View to assist in the review and analysis of the most effective way to terminate the Empower Retirement Plan as part of the wind-down process. The plan was established in the mid 1960's under the management and governance of the Oakland-Alameda County Coliseum, Inc., (OACC, Inc.), the predecessor to the Oakland-Alameda County Coliseum Authority. The plan was established to provide a defined benefit pension plan for OACC, Inc., employees. When the Authority was created, the plan was closed since the employees did not become employees of the Authority, and the Authority has never had employees. There are currently approximately thirty (30) participants in the plan. There are thirteen (13) participants who are vested but are not currently receiving benefits, of which four (4) are deceased. We are searching the records to locate participants who are not receiving benefits so they can apply for retirement or elect to receive their cash balances. We are working with Sage View and Empower to try to locate as many of these people or their beneficiaries as possible so we can determine their status or cash them out. Empower has indicated they are interested in taking over the plan for the current retirees and any of the remaining participants if they are retirement eligible for a yet to be determined cost, which preliminarily looks favorable. We will have an update at the December meeting.

# 2. Post June 30, 2026, Event Requests

The Board has approved event requests post June 30, 2026, for the Arena and established an Ad Hoc committee to provide guidance to the staff for requests after December 31, 2026, and for Stadium event requests after June 30, 2026. There are several event requests pending for both the Arena and the Stadium and the Ad Hoc committee has a meeting scheduled for November 21, 2025 to consider these. We may need the consent from both of the proposed buyers of the property for some of the requests. JPA counsel is reviewing these and will be providing guidance. It is in all of the parties' interest to book as many of the events possible to maximize event revenues no matter who owns the properties. This is becoming a challenge because promoters need to book events well into the future and the more we can tell them with certainty, the better the chance for success.

# 3. Final Bond Payments

The Authority issued bonds in 1995 to renovate the Stadium and in 1996 to renovate the Arena. The Stadium bonds were paid off in February 2025, and the Arena bonds will be paid off in February 2026. There are no other bonds outstanding. The bond covenants had certain restrictions regarding what the JPA could and could not do, principal among these were both facilities were to be operational and maintained and could not be sold until both Stadium and Arena bonds are retired. Once the final payments are made on the Arena bonds next February, all restrictions related to the bonds are removed and the City and County are no longer bound by any of the bond restrictions. The City and County will be free to do whatever it chooses, subject to the terms of their purchase-sale agreements and disposition agreements.
