RESOLUTION APPROVING AND ADOPTING ADDITIONS TO THE TICKET DISTRIBUTION POLICY AND AUTHORIZING THE EXECUTIVE DIRECTOR TO TRANSMIT THE ADDITIONS TO THE TICKET POLICY TO THE PRESIDING JUDGE OF THE SUPERIOR COURT, ALAMEDA COUNTY

WHEREAS, the Amended and Restated Joint Exercise of Powers Agreement ("JPA Agreement") between the City of Oakland ("City") and the County of Alameda ("County") established the Oakland-Alameda County Coliseum Authority ("Authority") whose powers are exercised by a Board of Commissioners appointed by the City and the County; and

WHEREAS, Section 933 of the California Penal Code requires the Authority to formally comment on Grand Jury findings and recommendations which pertain to matters under the control and authority of the Authority; and

WHEREAS, a portion of the 2017-18 Grand Jury Final Report contained a report captioned "Coliseum Ticket Bonanza" that pertained to matters under the control and authority of the Authority and to which the Authority is required to respond; and

**WHEREAS**, in response to the Grand Jury Report, the Authority formed an advisory committee to formulate revisions to the Authority's existing ticket policy; and

**WHEREAS**, the advisory body has recommended additions to the current "Policy for the Distribution of Tickets";

**NOW THEREFORE BE IT RESOLVED** that Board does hereby adopt the "JPA Suite Ticket Distribution Policy", a copy of which is attached to this Resolution, as additions to the JPA's "Policy for the Distribution of Tickets"; and

**BE IT FURTHER RESOLVED** that the Authority's Executive Director shall prepare a letter and transmit the "JPA Suite Distribution Policy" to the Presiding Judge of the Superior Court, Alameda County.

# STAFF REPORT

# April 12, 2019

**Background:** In June of 2018 the Alameda County Grand Jury in its Final Report addressed the issue of ticket distribution for the JPA suite at arena games/events. The JPA Board then directed its Executive Director to assemble a committee to address the report and the policies guiding ticket distribution. This committee was comprised of 7 members, some board members, outside management, and JPA staff. The committee met during the fall of 2018 and submitted a formal response back to the Grand Jury in January 2019. As a result of the committee's work, there are going to be some revisions in how we distribute tickets and improve enforcement of compliance on the 802 forms.

# Proposal:

- Each board member will have a set allocated number of games /events where they can use the suite for charity and community organizations
- The allocation procedure will be based on board seniority and rotated until all have been allocated
- The remaining games/events will be used for JPA business development and promotion
- There will be enhanced enforcement of the 802 forms for compliance
- All Board Members are asked to send written report to the JPA Executive Director if they see or hear of anything concerning when attending an event
- Tickets are never to be used in anyway for personal financial profit

Recommendation. Staff recommends the Board approve the ticketing distribution proposal as presented

# JPA SUITE TICKET DISTRIBUTION POLICY

The JPA has one suite for all events with 20 tickets and 4 parking passes

# **Warriors and Events Suites- Arena**

- Each elected official (Board member) will have total access to 5 games / events for community and charitable organizations
- Each appointed Board member will receive 1 game / event for community and charitable organizations

# A's and Coliseum Event Suites- Stadium

- Each elected official (Board member) will have total access to 12 games / events for community and charitable organizations
- Each appointed Board member will receive 2 games / event for community and charitable organizations

# **Distribution Selection Process**

Based on seniority a schedule of games/events will be distributed to each member.
 The elected officials will each select 2 events at a time and rotate until all have been used.
 The appointed members will each select 1 game/event at a time until all used.

# The Charity and Community

Selection process will reside with each official in their office and with each appointed Board member

# 802 Compliance

At the time of actual ticket distribution, the 802 -reporting form MUST be completed and signed

# **Report Concerns**

 If at any time any Board member receives and uses a ticket, observes or hears of operational or facility concerns, they are asked to call or write directly to the Coliseum Authority, Executive Director

# No Resale of tickets

At no time are any tickets to be sold for financial benefit.

# **Ticket Eligibility**

All remaining tickets for games and events will be distributed in accordance with JPA eligibility list
