#### 1. Third Quarter Budget Report

The third quarter is all positive, showing we are headed for a very successful budget year. We are projecting a surplus of revenues over expenditures by a few million dollars. We will not have final numbers until after the close of the fiscal year but barring any hiccups, we are in positive territory. The surplus is a combination of revenues exceeding budget and expenditures trending below budget.

#### **Revenues and Expenditures**

The largest revenue source is the contribution from the City and County in the amount of \$9,805,000 and the second largest category is the Warriors debt service payment. The revenues from all sources are projected to exceed the budget by \$1,600,000.

Administration, Legal and Audit expenses are all projected to come in under budget by year end. Coliseum Operations, the largest expenditure category, is projected to be \$4,236,000 below budget. Capital Outlay is projected to be about \$4,000,00 under budget due to delays in purchasing equipment or contract negotiations. There will be some carryover into next fiscal year.

#### 2. Proposed Budget FY 2025-26

Submitted for your approval is the proposed budget for FY 2025-26 in the amount of \$32,909,000.

Revenues, Fund Balance and City and County contributions total \$32, 909,000, and expenditures for all categories total \$32,909,000.

#### **Revenues, Fund Balance and City-County Contributions**

Revenues are estimated at \$11,369,000, City and County contributions are \$19,000,000, and Fund Balance \$2,540,000.

The largest source of revenues is the Warriors debt service payment of \$5,231,000. This is the final payment by the Warriors and is used to offset the same amount under expenditures. We

have budgeted \$1,600,000 for interest income, and \$1,000,000 for advertising income, and \$3,323,000 in facility fees, and \$215,000 in cell tower leases.

#### **Expenditures**

There is little change in Administration, Audit Fees, and Management Fees. Capital Outlay is substantially reduced from last year by \$4,000,000. There is an increase in legal expenses in anticipation of increased litigation costs. The largest increase is approximately \$3,395,000 over last year for Coliseum operations, due in part by having to absorb certain operations cost previously covered by the A's.

Even with the debt service for both the Arena and the Stadium being retired as of February 1, 2026, a City and County subsidy will continue to be required as long as they continue to own and operate the Stadium. Given past performance, the Stadium requires a very deep subsidy of \$12,000,000 to \$14,000,000 a year if it continues to be used.

We recommend approval of the proposed budget for FY 2025-26.

#### 3. Levy Premium Foodservice

Levy Premium Foodservice is the current concessionaire for the Arena. The contract expires on August 31, 2025. The contract was entered into on September 21, 2021 and we have negotiated an amendment to the existing contract to extend the term for ten (10) months to June 30, 2026. We are proposing to extend the term to align with the AEG contract which terminates on June 30, 2026. As long as the JPA continues operations at the Arena, we will need a concessionaire.

For the ten month period we are proposing the following rate structure:

#### **Concession Rates**

All Receipts 34.5% Premium/Catering 20.0% 50.0% Subcontracting Income

#### **Current Rate Structure**

Concessions \$0 - \$3,000,000 @ 35.0%

\$3,000,000 - \$5,500,000 @ 42.5 %

\$5,500,000 + @ 45.0%

Premium/ Catering \$0-650,000 @ 20%

\$650,000 + @25%

After careful analysis and based on the short duration of the extension and prospect of the number and type of events scheduled for the Arena, we conclude that the modified rate structure is fair and reasonable. Accordingly, we recommend approval of the resolution extending the existing contract for additional ten months.

**BE IT FURTHER RESOLVED** that the Authority's Executive Director is hereby authorized to take such actions necessary to implement the Budget, including coordination with AEG to appropriately allocate resources to maintain and secure the Coliseum Complex.

# FIRST AMENDMENT TO THE ARENA CONCESSION LICENSE AGREEMENT

THIS FIRST AMENDMENT TO THE ARENA CONCESSION LICENSE AGREEMENT (this "First Amendment") is made and entered into on June 20, 2025, and effective as of September 1, 2025 (the "Effective Date"), by and between the Oakland-Alameda County Coliseum Authority, a joint exercise of powers authority created by the City of Oakland and the County of Alameda (the "Concession Licensor") and Levy Premium Foodservice Limited Partnership, an Illinois limited partnership ("Concession Licensee").

#### RECITALS

WHEREAS, the parties entered into a certain Arena Concession License Agreement dated September 21, 2021 (the "Agreement"), granting Concession Licensee the exclusive right to operate all food and beverage concession services in the Oakland Arena; and

WHEREAS, the parties desire to amend the Agreement to extend the term and establish commission rates for the extended term, as more fully described below.

**NOW, THEREFORE,** in consideration of the mutual covenants herein granted and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. All terms used herein and not otherwise defined shall have the meanings ascribed to them in the Agreement.
- 2. The current term expires August 31, 2025. As of the Effective Date, the term of this Agreement is extended to June 30, 2026 (the "Extension Term").
- 3. During the Extension Term, the Concession Licensee shall pay the following Commissions each Month to the Concession Licensor based on Annual Gross Receipts.

Concessions	All Receipts	34.5%
Premium/Catering	All Receipts	20.0%
Subcontracted Income	All Receipts	50.0%

4. Except as specifically modified by this First Amendment, the terms and conditions of the Agreement shall remain in full force and effect, and nothing in this First Amendment shall modify or alter the rights and obligations of the parties under the Agreement. This First Amendment supersedes all prior oral or written agreements with respect to the subject matter hereof.

- 5. This First Amendment may be executed in two or more counterparts, each of which shall be an original, but all of which taken together shall constitute one and the same Agreement.
- 6. In the event of any conflict between the terms of the First Amendment and the language of the Agreement, the terms of the First Amendment shall control.

WHEREAS, TP Windows, Inc. ("TP Windows") and AEG Management Oakland, LLC ("AEG"), on behalf of the Authority, entered into a "Contract for Construction" (the "Agreement") for TP Windows to replace existing glass and silicone gaskets at the Arena (the "Work"); and

**WHEREAS**, a dispute arose between AEG and TP Windows regarding payment to TP Windows for work performed beyond the original scope of the Agreement; and

WHEREAS, TP Windows filed suit against the Authority and AEG in Alameda Superior Court, Case No. 22CV008091, demanding payment for breach of contract and other claims (the "Litigation"); and

**WHEREAS**, the parties participated in mediation and, without any admission of liability or fault, agreed to resolve the Litigation by payment to TP Windows of \$150,000; and

**WHEREAS**, staff for the Authority and AEG agreed to equally allocate the payment obligation with each contributing \$75,000, subject to approval by the Board; and

**WHEREAS**, the Board desires to settle the Litigation and to approve the contribution allocation with AEG;

**NOW THEREFORE BE IT RESOLVED** that the Board does hereby approve the Settlement Agreement, a copy of which is attached to this Resolution, and the contribution allocation with AEG, and authorizes the Executive Director to execute the Settlement Agreement and to take all steps necessary to make payment of the sum of \$75,000 to TP Windows, Inc.
