RESOLUTION RETROACTIVELY APPROVING A SETTLEMENT AGREEMENT WITH POLR LLC, MOHAMMED ALARBESH, SIDDIQ JIHAD AND KIM MITCHELL AND RATIFYING THE EXECUTIVE DIRECTOR'S EXECUTION OF THE SETTLEMENT AGREEMENT ON BEHALF OF THE AUTHORITY AND REFUND OF THE \$50,000 DEPOSIT PAID BY POLR LLC

- WHEREAS, the Amended and Restated Joint Exercise of Powers Agreement ("JPA Agreement") between the City of Oakland ("City") and the County of Alameda ("County") established the Oakland-Alameda County Coliseum Authority ("Authority") whose powers are exercised by a Board of Commissioners appointed by the City and the County; and
- WHEREAS, POLR LLC and AEG Management Oakland, LLC ("AEG") entered into an undated Event License Agreement (the "Agreement"), containing the terms and conditions for POLR to produce the KBLZ 40th Anniversary Concert in the Oakland Arena on November 27, 2019 (the "Event"); and
- **WHEREAS**, the Authority has engaged AEG to perform the day-to-day management of the Oakland Arena on their behalf; and
- WHEREAS, as a condition of the Agreement, POLR made a non-refundable deposit of Fifty Thousand Dollars (\$50,000) to reserve the Oakland Arena for the Event (the "Deposit"); and
- WHEREAS, a dispute arose between AEG and POLR regarding the adequacy of funding provided by POLR for facility expenses estimated to be incurred by AEG for the Event, which dispute resulted in AEG cancelling the Event and retaining the non-refundable Deposit; and
- WHEREAS, legal counsel for Siddiq Jihad and Kim Mitchell (collectively, "Promoters") alleged that AEG had breached the Agreement with POLR, violated Title II of the Civil Rights Act of 1964, and defamed Promoters by cancelling the Event (the "Claims"); and
- **WHEREAS**, the Promoters are not parties to, but claim to be third party beneficiaries of, the Agreement; and
- WHEREAS, without any admission of liability or fault, the Board desires to settle fully and finally any actual or potential Claims by POLR, its Managing Member Mohommad Alarbesh, and the Promoters against the Authority, the City of Oakland, and the County of Alameda; and
- NOW THEREFORE BE IT RESOLVED that the Board does hereby retroactively approve the Settlement Agreement, a copy of which is attached to this Resolution; and
- **BE IT FURTHER RESOLVED** that the Board ratifies the Executive Director's execution of the Settlement Agreement and refund of the \$50,000 deposit paid by POLR, LLC.

RESOLUTION AUTHORIZING THE TRANSFER OF \$20 MILLION IN UNASSIGNED FUND BALANCE FROM THE GENERAL FUND TO THE CITY OF OAKLAND (\$10 MILLION) AND THE COUNTY OF ALAMEDA (\$10 MILLION)

WHEREAS, the Amended and Restated Joint Exercise of Powers Agreement ("JPA Agreement") between the City of Oakland ("City") and the County of Alameda ("County") established the Oakland-Alameda County Coliseum Authority ("Authority") whose powers are exercised by a Board of Commissioners appointed by the City and the County; and

WHEREAS, the City and County annually contribute substantial subsidies to support the operations of the Authority and to satisfy the annual debt service obligations of the Authority; and

WHEREAS, the Authority has a sizable unassigned fund balance in its general fund of approximately \$31 million; and

WHEREAS, the arbitration between the Authority and the Golden State Warriors has concluded with a final order obligating the Warriors to pay the shortfall between the Arena revenue and bond debt service; and

WHEREAS, the Board of Commissioners has determined that the City and County should be reimbursed with unassigned fund balance in amounts generally equal to the debt service contributions advanced for the Warriors' obligation;

NOW THEREFORE BE IT RESOLVED that the Board does hereby authorize the County Auditor-Controller, in her capacity as Treasurer of the JPA, to transfer a total of \$20 million in unassigned fund balance with payments of \$10 million to the City of Oakland and \$10 million to the County of Alameda.

1. OES Planning and Coordination for use of the Coliseum Parking Lot

For the last four weeks we have been consumed with the preparation and coordination of mass vaccinations at the Coliseum parking lot. This effort first began in coordination with the Alameda County Incident Management Team. Several meetings were held to review the logistics regarding access, site plans, adequate lighting in the parking lot, WiFi capability, security, water, tents, chairs, staffing needs, etc., including coordination with the County Health Department. Once the Governor announced that the Oakland facility had been designated as a federal designated site for mass vaccinations, with the California Office of Emergency Services taking on the responsibility for the logistics and all the accommodations, our focus shifted to identifying what OES would be responsible for and what assistance would be needed from the JPA/ASM.

We have held daily meetings, both in-person and by Zoom, with OES and the Office of General Services to coordinate the very complex logistics for this operation. In addition to having as many as 6,000 persons on the site for vaccinations each day. OES is bringing 600 plus personnel to execute the plan. We have reached agreement on who is responsible for what and when, including the protection of the Authority's property not used by OES. We have also entered into a rental agreement for use of the lot.

The plan is to start with a soft opening on Tuesday the 16th and move to full opening by the weekend. There are still several moving parts as of the time of this writing. I will update the Board at the meeting on February 19, 2021 with any significant new developments.

At the last Board meeting, I suggested given the continuing requests we were receiving from various health care providers, an ad hoc task force consisting of various entities and individuals could bring a more coordinated strategy to best ensure maximum outreach to the community, especially communities that have been historically underserved. Commissioners Kaplan, Reid, and Miley volunteered, along with Dave Kaval of the A's. The County Administrator and City Administrator have also agreed to assist. Representatives from a couple of foundations have also been suggested to assist in this effort. At the first meeting of the group, Vice-Mayor Kaplan was designated as Chair. The group has no authority to implement anything. It is a collaborative

effort to bring together a number of government, private sector, and community resources to first and foremost ensure maximum outreach to underserved communities in the County, engage community based organizations in the effort, and identify effective communication strategies to get people registered and vaccinated. The Task Force is not a JPA task force, though the idea originated here. It is of a coalition of the willing. Commissioner Kaplan is on the agenda to give a report on the work of the task force.

2. Status of Negotiations with Levy for New Contract

We have had several rounds of negotiations with representatives of Levy regarding a new contract for food and beverage services at the Oakland Arena. We have reached tentative agreement on most of the salient points and believe we will be able to reach agreement on the outstanding ones by the time of the Board meeting on February 19, 2021. If we are successful, we will bring a resolution in March seeking approval. In the meantime, we have instructed the Bigelow Companies to continue to develop an RFP should the negotiations with Levy fail.

3. Status of The Drive-in Movies Analysis

We recommend that when circumstances permit, we have a trial run for one week. In order to break even, we need to show two movies per night. The cost for the projector and screen is based on the availability of the rental company's supply. The weather elements, e.g., rain and wind can pose issues with the screen and projector and must be taken into account for setup. We have considered a LED wall but it is too expensive to purchase. The estimated cost is \$600,000, plus additional expense for framing and building. We are considering a 400 car limit per night, dual sided screen with 200 cars on each side. Daylight saving time starts on March 14, sunset will be at 7:16 and movie times would start at 8 p.m. and 10:30 p.m. With the main lot being used for mass vaccinations, we will need to find a way to have the movies on the South side and not conflict with the vaccinations operations. We continue to explore ways to make this work so as not to have to subsidize the event, given the current financial condition of the Authority.
